("AGREEMENT")

I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity. I give permission to Afrim's Sports to use, without limitation or obligation, photographs, film footage, my child's image/voice as well as my own for purpose of promoting or interpreting Afrim's Sports programs.

2.
